THE SHELTER CLINIC AND SPAY AND NEUTER CLINIC PROVIDE ESSENTIAL MEDICAL SERVICES TO BOTH SHELTER ANIMALS AND THE BROADER COMMUNITY, INCLUDING VACCINATIONS, BASIC TREATMENT, AND HIGH-VOLUME SPAY/NEUTER SURGERIES. IN 2025, THE PROGRAM PERFORMED 4,509 SPAY/NEUTER SURGERIES AND ADMINISTERED APPROXIMATELY 19,000 VACCINATIONS, HELPING TO REDUCE ANIMAL OVERPOPULATION AND IMPROVE COMMUNITY ANIMAL HEALTH. THE SANTA FE ANIMAL SHELTER IS THE LARGEST ANIMAL SHELTER AND CARE FACILITY IN NORTHERN NEW MEXICO, SERVING MORE THAN 25,000 LOST, STRAY, ABANDONED, INJURED, AND OWNED ANIMALS ANNUALLY. AS AN OPEN-ADMISSION SHELTER, WE CONTRACT WITH THE CITY OF SANTA FE AND SANTA FE COUNTY TO PROVIDE CARE FOR HOMELESS AND STRAY ANIMALS AND OFFER RESOURCES TO HELP FAMILIES KEEP THEIR PETS AT HOME.

ANIMAL CARE INCLUDES SHELTERING, DAILY CARE, BEHAVIORAL SUPPORT, AND ENRICHMENT, AS WELL AS ADOPTION SERVICES AND THE ANIMAL RESOURCE CENTER, WHICH PROVIDES COMMUNITY-BASED ASSISTANCE, INCLUDING PET RETENTION SUPPORT AND REHOMING RESOURCES. IN 2025, THE SHELTER TOOK IN 3,255 ANIMALS AND MAINTAINED A 94.0% LIVE RELEASE RATE. THE ADOPTION PROGRAM PLACED 2,097 ANIMALS INTO PERMANENT HOMES, REUNITED 569 LOST PETS WITH THEIR FAMILIES, AND PROVIDED FOSTER CARE FOR 1,454 ANIMALS.

THE CASA (COMMUNITY ASSISTANCE FOR SANTA FE ANIMALS) PROGRAM IS A VITAL SAFETY NET TO KEEP PETS AND THEIR PEOPLE TOGETHER DURING TIMES OF FINANCIAL HARDSHIP. CASA SUPPORTS PET FAMILIES BY PROVIDING FREE OR LOW-COST SPAY/NEUTER SERVICES, VACCINATIONS, PET FOOD, ASSISTANCE WITH UNEXPECTED VETERINARY EXPENSES, AND SUPPORT WITH CITY AND COUNTY-RELATED FEES. ADDITIONAL SERVICES INCLUDE MICROCHIPPING, ID TAGS, LICENSING, TEMPORARY HOUSING SOLUTIONS, AND PROTECTIVE SUPPORT FOR PETS IN CRISIS.
